Probable cause, for the purpose of determining a motion to suppress, requires only that the issuing magistrate have a substantial basis for concluding that there is probable cause to believe that contraband or evidence is located in a particular place. *Illinois v. Gates*, 462 U.S. 213, 239-40, 103 S.Ct. 2317, 2332, 76 L.Ed.2d 527, 548 (1983). While the original affidavit in this case is defective, the warrant itself clearly sets out the basis for probable cause. The magistrate having made a determination of probable cause, we agree with the district court that the Leon exception to the exclusionary rule applies, and that the evidence seized pursuant to the valid warrant should not have

been suppressed. 11 The judgment of the district court is AFFIRMED. 1 The government moved to stay the appeal pending the Supreme Court's decision in Massachusetts v.
